Buyer agrees to pre-pay seller \$1.79 per gallon, or \$1.94 per gallon booked for all gallons. Pre-booked gallons will be eligible for a .10 cent per gallon discount if paid by January 31st, 2023. Applicable account service fees will apply for balances carried during this contract period. For gallons pre-paid, but not delivered, a credit will be issued to your account after January 31st, 2023. Gallons in excess of booked or pre-paid quantity will be charged at the best market rate available.

SELLER agrees to deliver Propane, up to the agreed upon gallons, to BUYER from the contract date through January 31st, 2023 on a Scheduled Delivery basis, at the SELLERS discretion, with the first delivery to be at the seller’s convenience. Deliveries will be made to the location listed above unless otherwise noted here. Pre-paid and booked gallons are an estimate. Seller is not obligated to deliver a specified quantity, and customer does not commit to purchase a specified quantity. Seller is not liable for delay, default, or impossibility of performance on its part due to an act of God, the public enemy, government restraints, regulations, shortages, riots, strikes, lockouts, machinery breakdowns, civil disturbances of any nature or any act happening beyond its control.

Buyer agrees that account balances must be maintained in a current status. Should buyer be considered in default according to Consumer’s Co-op Oil Company’s credit policy, seller shall reserve the right to withdraw from the booking agreement without notice. Discontinuation of seller as the sole supplier of propane during the booking agreement period may result in the termination of the booking agreement by the seller. Seller reserves the right to invoice buyer for the difference between the booking agreement price and OPIS LP Price - Conway In-Well (Any) plus \$0.45 per gallon or local rack plus \$0.45 per gallon for all gallons delivered during the booking agreement period should buyer cancel the booking agreement or discontinue seller as the sole supplier of propane for the booking agreement period.

This Propane Booking Agreement will be executed when the signed agreement and payment (pre-paid gallons) is received at Consumers Co-op, 758 Phillips Blvd., PO Box 668, Sauk City, WI 53583. A copy of the finalized agreement will be mailed back to you. Buyer acknowledges receipt of June 2021 Customer Awareness letter containing LP safety information and various program details.
